

DEFENCE FORCE REMUNERATION TRIBUNAL

DETERMINATION NO. 2 OF 2000

SALARIES OF LEGAL OFFICERS

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*:

Citation

1. This Determination may be cited as Determination No. 2 of 2000, Salaries of legal officers (Determination No. 6 of 1992 – Amendment).

Commencement

2. This Determination commences on 16 March 2000.

Amendment

3. Determination No. 6 of 1992, Salaries, as amended, is amended as set out in this Determination.

New clause 11A (Legal salary payable to certain legal officers not performing legal duties)

4. After clause 11, insert:

“11A.1 This clause applies to an officer who ceases, or has ceased, to perform the duties of a legal officer for reasons approved by the CDF and who:

- (a) is on short service commission or who has less than 6 years to serve until reaching compulsory retirement age: or
- (b) has applied for a short service commission before 16 March 2000 and is subsequently granted such a commission.

“11A.2 For subclause 11A.1, the CDF must have regard to:

- (a) the duties the officer will perform;
- (b) the expected period of these duties;
- (c) the relevance of these duties to the officer’s future responsibilities as a legal officer; and
- (d) the career progression of the officer within the legal stream.

“11A.3 The officer is entitled, during the relevant period, to the rate of salary that would otherwise be payable to the officer under Schedule 4A during the relevant period

“11A.4 In this clause, ‘the relevant period’ means:

- (a) the period beginning on the day on which the officer ceases to perform the duties of a legal officer and ending 3 years after that day; or
- (b) if the officer has ceased to perform legal duties before 16 March 2000 – the period beginning on 16 March 2000 and ending 3 years after that day”.

New clause 15A (Rate of salary – legal officer)

5. After clause 15, insert:

“15A.1 This clause applies to a legal officer whose rank is specified in column 1, 2 or 3 of Schedule 4A and who:

- (a) is on a short service commission;
- (b) has less than 6 years to serve until reaching compulsory retirement age; or
- (c) has applied for a short service commission before 16 March 2000 and is subsequently granted such a commission”.

“15A.2 The rate of salary applicable to a legal officer is the rate specified in column 4 of Schedule 4A opposite the officer’s rank in column 1, 2 or 3”.

New clause 23A (Rate of salary – legal officer)

6. After clause 23, insert:

“23A. The rate of salary applicable to a legal officer is the rate specified in column 4 of Schedule 10A opposite the officer’s rank in column 1, 2 or 3’.

New Schedule 4A (Scale of annual rates – legal officer of the Permanent Forces)

7. After Schedule 4, insert the Schedule set out in Attachment A.

New Schedule 10A (Scale of annual rates – legal officer of the Reserve Forces)

8. After Schedule 10, insert the Schedule set out in Attachment B.
