

# **DEFENCE FORCE REMUNERATION TRIBUNAL**

## **DETERMINATION NO. 5 OF 2002**

### **AMENDMENT OF REFERENCES TO SALARY SCHEDULES**

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*:

#### **Commencement**

1. This Determination commences on 23 April 2002.

#### **Amendment**

2. Determination No. 6 of 1992, Salaries, as amended, is amended as set out in this Determination.

#### **Subclause 13.1 (Rate of salary for officer)**

3. Substitute:

“13.1 The rate of salary applicable to an officer is the rate specified in column 4 of Schedule 2 opposite the officer’s rank in column 1, 2 or 3.”

#### **Clause 14 (Rate of salary on advancement from other rank)**

4. Substitute:

“14. The rate of salary applicable to an officer with a rank specified in column 1, 2 or 3 of Schedule 3 who successfully completes officer training, having been a member who held the rank of Sergeant or a higher rank in the Army, or an equivalent rank, immediately before the commencement of the training, is the rate specified in column 4 of Schedule 3 opposite the officer’s rank.”

#### **Clause 15 (Rate of salary – medical and dental officer)**

5. Substitute:

“15.1 The rate of salary applicable to a medical or dental officer is the rate specified in column 4 of Schedule 4 opposite the officer’s rank in column 1, 2 or 3.”

“15.2 The rate of salary applicable to an officer who is undertaking compulsory residency is the rate specified in column 4 of Schedule 4 for an officer who is undertaking compulsory residency.”

**Clause 17 (Rate of salary – member other than officer)**

6. Substitute:

“17. The rate of salary applicable to a member other than an officer is the rate specified for the member’s pay group in column 4 of Schedule 6 opposite the member’s rank in column 1, 2 or 3.”

**Clause 22 (Rate of salary – officer)**

7. Substitute:

“22. The rate of salary applicable to an officer is the rate specified in column 4 of Schedule 9 opposite the officer’s rank in column 1, 2 or 3.”

**Clause 23 (Rate of salary – medical and dental officer)**

8. Substitute:

“23. The rate of salary applicable to a medical or dental officer is the rate specified in column 4 of Schedule 10 opposite the officer’s rank in column 1, 2 or 3.”

**Clause 26 (Rate of salary – member other than officer)**

9. Substitute:

“26. The rate of salary applicable to a member other than an officer is the rate specified for the member’s pay group in column 4 of Schedule 13 opposite the member’s rank in column 1, 2 or 3.”
