

DEFENCE FORCE REMUNERATION TRIBUNAL

DETERMINATION NO. 13 OF 2004

SPECIALIST SALARY STRUCTURE – CHAPLAINS

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*:

Commencement

1. This Determination commences on date of signature.

Amendment

2. Determination No. 6 of 1992, Salaries, as amended, is amended as set out in this Determination.

Subclause 16.1 (Rate of salary – Chaplain of the Permanent Force)

3. Substitute:

“Rate of salary – Chaplain of the Permanent Force on specialist salary structure

16.1 The rate of salary applicable to a Chaplain on a fixed tenure appointment is the rate specified in column 2 of Schedule 5 opposite the Chaplain’s classification in column 1a and competency level in column 1b.”.

Subclause 16A.1 (Rate of salary – Chaplain of the Permanent Force), title only

4. Substitute:

“Rate of salary – Chaplain of the Permanent Force not on specialist salary structure”

Subclause 24.1 (Rate of salary – Chaplain)

5. Substitute:

“Rate of salary – Chaplain of the Reserve Forces on specialist salary structure

24.1 The rate of salary applicable to a Chaplain is the rate specified in column 2 of Schedule 11 opposite the Chaplain’s classification in column 1a and competency level in column 1b.”.

Schedule 5 (Scale of annual rates – Chaplain of the Permanent Forces)

6. Substitute the Schedule set out in Attachment A.

Schedule 11 (Scale of daily rates – Chaplain of the Reserve Forces)

7. Substitute the Schedule set out in Attachment B.
