DETERMINATION NO. 2 OF 2009

SPECIAL FORCES - AMENDMENTS

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*.

1. This Determination corrects Determination No. 25 of 2008, Graded Other Ranks Pay Structure and has effect from the same date.

Subclause B.4.3 (Pay grade for a Warrant Officer Class 1)

2. Insert after subclause B.4.3.5:

“6. If a member of the Army is liable to be employed in a Special Forces capacity listed in the following table, then the member’s pay grade is increased to the pay grade listed in column 3.

Subclause B.5.2 (Pay grade for a member below the rank of Warrant Officer Class 1)

3. Insert after subclause B.5.2.4:

“5. If a member of the Army is liable to be employed in a Special Forces capacity listed in the following table, then the member’s pay grade is increased to the pay grade listed in column 3.

5. Amend the schedule in Attachment C by substituting for table item 9 under Army Pay Grade 8:

“9. Commando Grades 4 to 7”


Clause 14 (Transitional)

6. Amend the first sentence of clause 14 to read:

“A member who is paid as SAS Trooper Grade 2 on any day between 4 September 2008 and 11 June 2009 will be paid from that day as SAS Trooper Grade 3.”
