3 Authority

This instrument is made under section 58H of the Defence Act 1903.

4 Amendment

The following DFRT Determinations, as amended,¹ are amended as set out below.

- b. DFRT Determination No. 2 of 2017, *Salaries*, is amended as set out in Schedule 2 to this Determination.

5 Saving

- 1. A member who is participating in the undergraduate entry scheme and meets either of the following conditions, is to be paid according to the following table for the duration of their participation in the undergraduate entry scheme.
 - a. The member is eligible for a trainee rate of salary under Schedule B.13, Part 1, table item 4, of DFRT Determination No. 2 of 2017, *Salaries*, on the day before the commencement of this Determination.

b. The member has accepted a letter of offer from the ADF before the commencement of this Determination, which references the previous Schedule B.13, Part 1 table item 4, of DFRT Determination No. 2 of 2017, *Salaries*.
