Schedule 1 — Amendment

DFRT Determination No. 2 of 2017, Salaries

1 Section B.1.4 (Rate of salary for a senior officer)

At the end of the section, insert:

Note: This is the senior officer's salary for which superannuation contributions are payable.

2 Subsection B.1.5 (Rate of salary for a Lieutenant General)

At the end of the section, insert:

Note: The base salary of each pay point is the senior officer's salary for which superannuation contributions are payable.

3 Subsection B.1.6 (Career transition salary non-reduction provision)

Omit the section, substitute:

B.1.6 Salary non-reduction on ceasing appointment

- 1. This section applies to a senior officer who meets both the following conditions.
 - a. The senior officer's appointment to one of the following positions ceases.
 - i. Chief of Defence Force.
 - ii. Vice Chief of Defence Force.
 - iii. Service Chief.
 - iv. Chief Joint Operations.
 - b. The senior officer undertakes required activities that support their resignation, retirement or transfer to the Reserves.
- 2. The senior officer's annual salary is equal to the amount of annual salary for which superannuation was payable on the last day of their appointment under paragraph 1.a.
- 3. The senior officer's eligibility for payment under subsection 2 ceases when the earlier of the following events occur.
 - a. The senior officer ceases to be in the Permanent Forces.
 - b. The senior officer is appointed or posted to a position in which they cease the activities under paragraph 1.b.

Schedule 2 — Transitional

1 Transitional — Chief Joint Operations

- 1. This section applies to a senior officer who meets both the following conditions.
 - a. The senior officer held the position 'Chief Joint Operations' at the commencement of this Determination.
 - b. After ceasing the appointment the senior officer is required to undertake activities that support their resignation, retirement or transfer to the Reserves.
- 2. The senior officer's salary is equal to the total remuneration payable on the last day of their appointment.
- 3. Eligibility for payment begins the day immediately after their appointment ceases and ends when the earliest of the following events occur.
 - a. The senior officer ceases to be in the Permanent Forces.
 - b. The senior officer is appointed or posted to a position in which they are required to cease the activities under paragraph 1.b.
 - c. Eight weeks after their appointment ceases.
