DETERMINATION NO. 4 OF 2012

PARATROOPER ALLOWANCE – AMENDMENT OF UNIT TITLES FROM FORCES COMMAND TO SPECIAL OPERATIONS COMMAND

The Defence Force Remuneration Tribunal makes the following Determination under section 58H of the *Defence Act 1903*.

Commencement

1. This Determination commences on the date of signature.

Amendment

2. Determination No. 2 of 2001, Paratrooper Allowance, as amended, is amended as set out in this Determination.

Clause 3 (Paratrooper Allowance – member on continuous full-time service), table

- 3. Delete the clause in its entirety and insert:
 - "3. A member who is a paratrooper rendering continuous full-time service is entitled to Paratrooper Allowance at the rate that applies to them in the table.

Clause 5 (Paratrooper Allowance – member of the Reserve Forces), table

4. Delete the clause in its entirety and insert:

"5. A member of the Reserve Forces who is a paratrooper is entitled to Paratrooper Allowance, for each day or part of a day the member renders Reserve service, at the rate that applies to them in the table.

Clause 6 (Allowance not payable)

5. Delete the whole of Clauses 6.1, 6.2, 6.3 and 6.4 and insert:

"6.1 A member is not entitled to more than one rate of Paratrooper Allowance at any time.

Exception: A member paid an amount under clause 5A is not subject to this limit.

- 6.2 A member is not entitled to an annual rate of Paratrooper Allowance during a period beginning more than six months after the day on which the member last made a parachute descent, unless the CDF approves payment during the period.
- 6.3 For subclause 6.2, the CDF must have regard to:
 - (a) the degree of illness or infirmity, if any, of the member which prevented the member from making a parachute descent;
 - (b) whether the illness or infirmity was caused by the member's own fault;
 - (c) the opportunity the member had to make a parachute descent during the period following the day on which the member last made a parachute descent; and

(d) any other reason preventing the member from making a parachute descent.

Note: If a member has a permanent medical restriction preventing them from conducting a parachute descent, refer to clause 6.5.

- 6.4 Determination No. 4 of 2008, Allowance for Specialist Operations (Column 5 of Schedules 1 and 2) and Determination No. 5 of 2008, Special Forces Disability Allowance (Column 6 of Schedule 1), prescribe whether a member receiving either of those allowances may also be paid Paratrooper Allowance.
- 6.5 Eligibility and payment of Paratrooper Allowance ceases from the date that a member is notified of a permanent medical restriction on their conducting a parachute descent."

Deeming and transitional

6. Insert after clause 7.2:

"Deeming and transitional

- 8.1 A member is taken to have met the posting-related eligibility conditions for this allowance between 1 March 2012 and the date this Determination commences if:
 - (a) the member's unit name changed on or after 1 March 2012 and the day this Determination commences; and
 - (b) the member's new unit name is included in a posting-related eligibility condition amended by this Determination.
- 8.2 To avoid doubt, a decision made in relation to the eligibility of a member before this Determination commenced is taken to continue to be effective in relation to that member as if the member met the eligibility condition as amended by this Determination."
