5 Schedule B.5 (Specialist Officer – Chaplain)

Delete Schedule B.5 in its entirety and insert the schedule at Schedule 1 to this Determination.

6 Transition and savings

1. **Competency level** in column 4 of Schedule 2 to this Determination means the competency level relevant to a Chaplain under the salary structure revised by this Determination. There are two parts to the competency level (CL) number:

- (a) the first number in a competency level (for example 'CL2') indicates the level of qualification and skill; and
- (b) the second number in a competency level (for example '-2') represents the increment.
- 2. On commencement of this Determination, a Chaplain holds the competency level in column 4 of Schedule 2 that corresponds to the member's circumstances on the day before commencement, described in paragraphs (a) to (c):
 - (a) the member's classification in column 1; and
 - (b) the member's pre-commencement competency level in column 2; and
 - (c) the member's experience in column 3.
