Delete the tables at Schedule B.5 in their entirety and insert the tables at Schedule 1 to this Determination.

7 Schedule B.17 (Senior Officer – Legal Officer)

After Schedule B.17, insert the schedule at Schedule 2 to this Determination.

8 Transitional

For the purpose of eligibility for salary increments, a member's increment anniversary date for a competency level in Division 5 is to be calculated by reference to the period beginning on the day the member first entered that Division. That period can be counted toward an increment under the salary structure introduced by Schedule B.18.
