EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 2 of 2021, Salaries – Air Intelligence Officer Employment Category – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedule B.2 of the Principal Determination to update the employment categories for the Air Force's Intelligence Officer employment categories. It amends the names of Intelligence Officer employment categories to Air Intelligence Officer and adds two skill grades/pay grade placements into the relevant tables.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 1 April 2021.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1–Air Intelligence Officer

Sections 1 to 6 omit and substitute the tables for pay grades 2, 3, 4, 5, 6, 7 and 8 in Part 4 of Schedule B.2 of the Principal Determination. The tables list the employment categories in Air Force that are paid at the pay grade specified in the relevant table. The employment category tables substitute 'Intelligence Officer' with equivalent 'Air Intelligence Officer' categories and insert additional Air Intelligence Officer employment categories to the tables for Pay Grade 5 and Pay Grade 6 (and any relevant Command associated command placements).
