#### **EXPLANATORY STATEMENT**

## Defence Force Remuneration Tribunal Determination No. 26 of 2021, Salaries – Navy Health Services Officer employment category – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the Defence Act 1903 (the Act) and in accordance with subsection 33(3) of the Acts Interpretation Act 1901 (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Part 2 of Schedule B.2 of the Principal Determination to add the Navy Health Services Officer employment category into the Graded Officer Pay Structure.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 3 March 2022.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1-Navy Health Services Officer employment category amendments

Sections 1 to 5 amend the tables for Pay Grades 2, 3, 5, 6 and 8 in Part 2 (Navy) of Schedule B.2 (Officer pay grades) of the Principal Determination. The tables are amended to insert 'Navy Health Services Officer' into Pay Grades 2, 3, 5, 6 and 8 in Part 2.
