# EXPLANATORY STATEMENT

## Defence Force Remuneration Tribunal Determination No. 27 of 2021, Salaries – Maritime Logistics Support Operations (Submariner) – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to make technical amendments that change the name of employment categories under Part 1 of Schedule B.11 of the Principal Determination. The skill grade names for 'Maritime Logistics Support Operations — SM' were inadvertently changed back to a previous naming by Defence Force Remuneration Tribunal Determination No. 14 of 2017, *Salaries — Navy Cryptologic Sailors — amendment* that commenced on 20 April 2018. This Determination restores the correct and current naming for these skill grades.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 3 March 2022.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

### Schedule 1—Maritime Logistics Support Operations employment categories amendments

Sections 1 to 3 amend the tables for Pay Grade 6 in Part 1 (Navy) of Schedule B.11 (Other rank pay grades) of the Principal Determination. The table lists the employment categories in Navy that are placed in Pay Grade 6. The tables are amended to omit 'Maritime Logistics Steward — SM' grades 2 to 4 from Pay Grade 6 in Part 1, and to insert 'Maritime Logistics Support Operations — SM' grades 2 to 4 into Pay Grade 6 in Part 1.
