EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal No. 2 of 2023, Salaries – Army Imagery Special and Air Force Imagery Specialist – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, *Salaries* (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend employment categories under Parts 2 (Army) and 3 (Air Force) of Schedules B.9 and B.11 of the Principal Determination to add the imagery specialist employment category into the Warrant Officer Class 1 pay structure and Other Ranks pay structure, respectively.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on the day after signature.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Rate of salary on becoming an officer - amendment.

Section 1 amends Pay Grade 5 in Part 2 (Army) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The table lists the employment categories in the Army that are paid at Pay Grade 5. The table is being amended to insert 'Army Imagery Specialist' into Pay Grade 5.

Sections 2 to 4 amends Pay Grade 5 in Part 3 (Air Force) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The table list the employment categories in the Air Force that are paid at Pay Grade 5. The table is being amended to insert 'Air Force Imagery Specialist' into and repeal item 31 and 32 from Pay Grade 5.

Sections 5 to 7 amends Pay Grades 4 and 5 in Part 2 (Army) of Schedule B.11 (Other rank pay grades) of the Principal Determination. The tables list the employment categories in the Army that are paid at Pay Grades 4 and 5. The tables are being amended to insert 'Army Imagery Specialist' into Pay Grades 4 and 5 in Part 2, and to remove item 80 from Pay Grade 5.

Sections 8 to 17 amend Pay Grades 4 and 5 in Part 3 (Air Force) of Schedule B.11 (Other rank pay grades) of the Principal Determination. The tables list the employment categories in the Air Force that are paid at Pay Grades 4 and 5. The tables are being amended to insert 'Air Force Imagery Specialist' into Pay Grades 4 and 5. The tables are also amended to repeal item 41 from Pay Grade 4, and items 43, 50, 51, 60, 61, 62 and 69 from Pay Grade 5.
