EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 4 of 2023, ADF allowances – Navy Submarine Capability Assurance Payment Eligibility Adjustment – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 11 of 2013, *ADF Allowances* (the Allowances Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Allowances Determination sets out provisions dealing with salary related allowances for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend section D.1.6 of the Allowances Determination which sets out the conditions for eligibility for the Navy's Submarine Capability Assurance Payment.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on the date of signature.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 - Navy Submarine Capability Assurance Payment Eligibility Adjustment amendment.

Section 1 amends section D.1.6 of the Allowances Determination which sets out the eligibility conditions for receiving the Submarine Capability Assurance Payment. The section is amended to remove paragraph D.1.6.c which provides a restriction on eligibility that prevents a submariner receiving the payment if they are serving a period of undertaking towards an individual or employment category bonus scheme related to submarine capability under section 58B of the Act.
