# 1 Paragraph D.2.3.2.c

Repeal the paragraph, substitute:

c. They have a Medical Employment Classification of J1, J2 or J3.

# 2 Paragraph D.2.3.2.d

Repeal the paragraph, substitute:

d. They have met all their mandatory annual awareness training for the year.

# 3 Section D.2.7

Omit "30 June 2024", substitute "1 July 2025".

# **EXPLANATORY STATEMENT**

# Defence Force Remuneration Tribunal No. 7 of 2023, ADF Allowances – Navy Retention Incentive Payment – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 11 of 2013, *ADF Allowances* (the Allowances Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Allowance Determination sets out provisions dealing with salary related allowances for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend eligibility criteria for the Navy Retention Incentive Payment and extend the eligibility period for an additional 12 months to 1 July 2025. The extension of the Navy Retention Incentive Payment by a further 12 months will allow time for the *Stay Onboard – People First* retention campaign and ADF Employment Offer Modernisation Program outcomes to be achieved. The extension will also allow time for a suite of financial and non-financial initiatives to be implemented to improve ADF recruitment and retention.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on Date of Signature

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### Schedule 1-Navy Retention Incentive Payment - amendment

Items 1 and 2 amends subsection D.2.3.2 of the Allowances Determination which set out the eligibility criteria for receiving the Navy Retention Incentive Payment, to assist with the administration of the payment. The changes are as follows.

- Item 1 repeals and substitutes paragraph D.2.3.2.c to remove the criteria that a member is to meet their individual readiness for at least 10 out of 12 months. The criteria now specifies that the member is to have a Medical Employment Classification of J1, J2 or J3, which are indicative of a member's employability and deployability.
- Item 2 repeals and substitutes paragraph D.2.3.2.d to remove the criteria that a member is to have completed and maintained currency in all components of mandatory annual awareness training during the 12 months preceding the date of payment. The criteria now specifies that the member is to have met all their mandatory annual awareness training for the year.

Item 3 amends section D.2.7 of the Allowances Determination to extend the Navy Retention Incentive Payment by a further 12 months, from "30 June 2024" to "1 July 2025".

Authority: Section 58H of the Defence Act 1903
