# EXPLANATORY STATEMENT

## Defence Force Remuneration Tribunal No. 12 of 2023, Salaries – Boatswain Mate Sailor – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend an employment category under Part 1 (Navy) of Schedule B.9 of the Principal Determination to add the Boatswain – Limited Navigation Watchkeeping Certificate employment category into the Warrant Officer Class 1 pay structure.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 7 October 2022.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

### Schedule 1 – Warrant Officer Class 1 pay grades amendment

Section 1 amends Pay Grade 5 in Part 1 (Navy) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The table lists the employment categories in the Navy that are paid at Pay Grade 5. The table is being amended to insert 'Boatswain – Limited Navigation Watchkeeping Certificate' into Pay Grade 5.
