EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 16 of 2023, Salaries – Airborne Electronics Analyst – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to adjust the pay grades for the Airborne Electronics Analysts following the review of the Air Force 'Airborne Electronics Analyst' employment category. Pay grades for this employment category are provided by Part 3 of Schedule B.9 and Part 3 of Schedule B.11 of the Principal Determination.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 18 January 2024.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Airborne electronics analyst amendment

Sections 1 to 6 amend Part 3 of Schedule B.9 and sections 7 to 11 amend Part 3 of Schedule B.11 of the Principal Determination which provide the pay grades for members who are Airborne Electronics Analysts in the Air Force. The pay grades have been adjusted following a review of the Air Force 'Airborne Electronics Analyst' employment category and the planned introduction of a ground-based stream. The following pay grades have been adjusted:

- Pay grades 4 to 8 of Part 3 of Schedule B.9, which provide the specific pay grades for Warrant Officer Class 1.
- Pay grades 4 to 8 of Part 3 of Schedule B.11, which provide the specific pay grades for Other Ranks.
