## EXPLANATORY STATEMENT

# Defence Force Remuneration Tribunal No. 2 of 2024, Salaries – Navy Intelligence Sailor Employment Categories – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend employment categories under Schedule B.9 and B.11 of the Principal Determination to amend the title of Cryptologic Sailor to Navy Intelligence Sailor as a consequence of the changes Navy is making in response to the rapidly changing cyber environment.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on the day of signature.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Navy Intelligence Sailor employment categories amendment.

Sections 1 to 4 amend pay grades 7 and 8 in Part 1 (Navy) of Schedule B.9 (Warrant Officer Class 1 pay grades) of the Principal Determination. The tables list the employment categories for Warrant Officers Class 1 in the Navy that are paid at the respective pay grade. The tables are being amended to remove the category of Cryptologic Sailor from the pay grades and include Navy Intelligence Sailor in line with the new employment category titles that are being introduced.

Sections 5 to 14 amend pay grades 3 to 7 in Part 1 (Navy) of Schedule B.11 (Other Rank pay grades) of the Principal Determination. The table lists the employment categories for other ranks in the Navy that are paid at the respective pay grade. The tables are being amended to remove the category of Cryptologic Sailor from the pay grades and include Navy Intelligence Sailor in line with the new employment category titles that are being introduced.
