EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal No. 3 of 2024, Salaries, Air Force Security Forces – amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to amend Schedule B.2 of the Principal Determination which sets out the employment categories for members an officer. These amendments reflect the modernisation of the Air Force Security Forces workforce.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 6 June 2024.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Air Force Security Forces employment category amendment

Sections 1 to 10 amend pay grades 2, 3, 4, 5 and 8 in Part 4 (Air Force) of Schedule B.2 (Officer pay grades) of the Principal Determination. The pay grades list the employment categories for Officers in the Air Force. The pay grades are being amended to remove Ground Defence and Security Police from the employment categories and to include the new employment category of Security Forces Officer.
