EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. XX of 2025, Naval Police Coxswain Officer amendment

This Determination is made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AI Act).

The purpose of this Determination is to establish additional pay grades, as agreed to under Matter 6 of 2025, for the Naval Police Coxswain Officer work group who are responsible for providing policing and security services to the Royal Australian Navy and the wider Australian Defence Force.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 1 August 2025.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Naval Police Coxswain Officer amendments

Items 1 to 5 amend pay grades 2 to 6 in Part 2 (Navy) of Schedule B.2 (Officer pay grades) of the Principal Determination. The tables list the employment categories for Officers in the Navy that are paid at the respective pay grade. The tables are being amended to establish additional pay grades, as agreed to under Matter 6 of 2025, for the Naval Police Coxswain Officer work group who are responsible for providing policing and security services to the Royal Australian Navy and the wider Australian Defence Force.
