EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 13 of 2025, Maritime and Surface Warfare Officer amendment

This Determination is made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (Al Act).

The purpose of this Determination is to establish a new pay grade placement for Maritime Warfare Officer and Surface Warfare Officer at Pay Grade 3.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 4 December 2025.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1 – Maritime and Surface Warfare Officer amendments

Items 1 and 2 amend pay grade 3 in Part 2 (Navy) of Schedule B.2 (Officer pay grades) of the Principal Determination. The table lists the employment categories for Officers in the Navy that are paid at pay grade 3.
