# **About this compilation**

# This compilation

This is a compilation of Defence Force Remuneration Tribunal Determination No. 14 of 1992: Language Allowance that shows the text of the law as amended and in force on 6 November 2025 (the *compilation date*).

The notes at the end of this compilation (the *endnotes*) include information about amending laws and the amendment history of provisions of the compiled law.

## **Uncommenced amendments**

The effect of uncommenced amendments is not shown in the text of the compiled law. #### Citation

1. This determination may be cited as Determination No. 14 of 1992, *Language Allowance*.

#### **Definition**

2. This table defines terms used in this Determination.

Term	Definition
Grade of language competency	Means the highest current grade of competency attained under the Defence Languages-other-than English (LOTE) Capability Model, as in force on 1 December 2016, by that member.
Level of language proficiency	Means the highest current level of proficiency attained under the Australian Defence Language Proficiency Rating Scale (ADLPRS), as in force on 1 December 2016, by that member.

# **Exercise of Powers by Chief of the Defence Force**

3. In this determination a reference to the Chief of the Defence Force is to be taken as including references to such other person as the Chief of the Defence Force authorises for the purpose of the provision in which the reference occurs.

# Application

- 4. This determination applies to a member who -
  - (a) is employed in a position where language skills are required and is required to use the language skills in the course of performing duty, or
  - (b) is not employed in such a position but who the Chief of the Defence Force certifies is required to be available at short notice for employment in such a position.

# **Specified languages**

5. The following table lists languages, grouped by degree of language difficulty, for which language allowance may be paid.

#### **Payment of Allowance**

- 7.1 A member who has attained a level of language proficiency or competency at the lower language level or above is entitled to be paid, on the date the member qualifies or subsequently requalifies, language allowance of the amount specified in clause 6 according to the level of language proficiency or competency of the member and the degree of language difficulty.
- 7.2 A member is also entitled to be paid language allowance for the language on the anniversary of the date the member qualifies or subsequently requalifies, but is not entitled to be paid twice in the same year.
- 7.3 Unless the Chief of the Defence Force so approves, having regard to the requirements of the Australian Defence Force, a member is not to be paid language allowance for more than one specified language.

## Member to be Taken to be Qualified

8. Where a member fails to requalify in a language but is employed in a position where language skills are used, and the member is able to qualify in certain language skills, the Chief of the Defence Force may approve that the member is to be taken to be qualified in the language at the lower level of proficiency.

#### **Payment in Special Circumstances**

- 9.1 A member who is not otherwise entitled to language allowance under this determination is entitled to be paid language allowance at the lower proficiency or competency amount if the Chief of the Defence Force certifies that the member is
  - (a) appropriately skilled in a language other than English or a specified language; and
  - (b) employed in a position where language skills are essential.
- 9.2 A member ceases to be entitled to be paid in accordance with this clause when the member ceases to be employed in a position where language skills are essential or where the Chief of the Defence Force revokes the certification.

#### Requalification

- 10.1 A member is not entitled to be paid language allowance unless the member requalifies at an interval of not more than three years.
- 10.2 The three year interval may be extended by a further period as authorised by the Chief of the Defence Force where Service requirements or compelling compassionate circumstances of the member make it impractical for the member to attend a requalification examination.
- 10.3 A member, posted for 12 months or more to a country where the native language is the same as the language for which the member is entitled to be paid language allowance, is not required to requalify during the period from the commencement of the posting to a date one year after the posting ceases.

10.4 A member posted as an instructor to the Defence Force School of Languages is not required to requalify in the language the member teaches for the period from the commencement of the posting to a date two years after the posting ceases.

# Qualification Attained at Other Than the Australian Defence Force School of Languages

11. A member who has acquired a specified language other than at the Defence Force School of Languages is not entitled to be paid language allowance at an amount above the intermediate language level of language proficiency on first qualifying, unless the Chief of the Defence Force determines a higher level of proficiency should apply.

# Repayment of Allowance

12. Where a member has been paid Language Allowance and the member ceases to be a member during the one year period immediately after becoming entitled to the allowance, that member is required to repay a proportion of the allowance determined in accordance with the following formula:

$$\frac{A}{365} \times B$$

where;

- **A** is the amount of Language Allowance paid to the member,
- **B** = 365 minus the number of days the member served after becoming entitled to Language Allowance.

#### **Date of Effect**

This determination will take effect on and from 5 November 1992.
