EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 19 of 2025, Army Marine Specialist employment categories transitional amendments

This Determination is made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (Al Act).

The purpose of this Determination is to restructure the Army Marine Specialist employment category on the Graded Other Ranks Pay Structure to formalise the required skill sets for the new Littoral Manoeuvre fleet.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 1 July 2026.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1—Army Marine Specialist amendments

Items 1 to 3 amend Part 2 of Schedule B.9, which provides the Warrant Officer Class 1 employment categories for Army. The following amendments have been made.

- The 'marine specialist manager tier A' employment category in pay grade 4 and 'marine specialist manager tier B' employment category in pay grade 5 have been removed.
- The 'marine specialist, tier master A' and 'marine specialist, tier master B' have been inserted into pay grade 6.

Items 4 to 8 amend Part 2 of Schedule B.11, which provides the other rank employment categories for Army. The following amendments have been made.

- The 'marine specialist, grade 1' employment category in pay grade 1 has been removed.
- The 'marine specialist, grade 2' employment category in pay grade 3 has been removed and the 'marine specialist, foundation 1' has been inserted.
- The following categories have been removed from pay grade 4 and replaced by 'marine specialist, foundation 2' and 'marine specialist, intermediate'.
 - Marine specialist, grade 3.
 - Marine specialist, advanced.
 - Marine specialist, manager.
 - o Marine specialist, supervisor.
- The 'marine specialist, advanced' employment category has been inserted into pay grade 5.
- The 'marine specialist, master' employment category has been inserted into pay grade 6.
