#### **EXPLANATORY STATEMENT**

# Defence Force Remuneration Tribunal Determination No. 20 of 2025, Salaries – Army driver specialist employment categories amendment

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 2 of 2017, Salaries (the Principal Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to restructure the Army driver specialist employment category in order to provide a more appropriately experienced, multi skilled and sustainable workforce for Army and the Joint Force.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that the Determination commences on 2 April 2026.

Section 3 provides that this instrument has authority under section 58H of the Defence Act 1903.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

#### <u>Schedule 1 – Army driver specialist amendments</u>

Items 1 to 3 amend Part 2 of Schedule B.9 of the Principal Determination, which provides the Warrant Officer Class 1 employment categories for Army. The 'transport operations manager, grade A' employment category has been moved from pay grade 4 to pay grade 5, and the 'transport operations manager, grade B' employment category has been moved from pay grade 5 to pay grade 6.

Items 4 to 12 amend Part 2 of Schedule B.11 of the Principal Determination, which provides the other rank employment categories for Army. The following amendments have been made.

- The 'driver specialist' employment categories in pay grades 1 and 2 have been renamed as 'driver'.
- The following employment categories have been removed from pay grade 3 and the 'driver heavy vehicle' employment category has been inserted.
  - o Driver specialist.
  - Driver specialist advanced.
  - o Operator heavy vehicle.
  - Operator heavy vehicle advanced.
  - Operator specialist vehicles.
- The 'transport operator supervisor' and 'transport operations manager' have been removed from pay grade 4 and the following employment categories have been inserted.
  - o Driver heavy vehicle advanced.
  - Operator specialist vehicle.
  - o Transport operations supervisor.

•	The 'operator specialist vehicles' employment categories at items 67 and 68 of pay grade 4 have
	been amended to replace 'vehicles' with 'vehicle'.

•	The 'transport operations supervisor' and 'transport operations manager' employment categories
	have been inserted into pay grade 5.
