EXPLANATORY STATEMENT

Defence Force Remuneration Tribunal Determination No. 21 of 2025, Miscellaneous amendments

This Determination amends Defence Force Remuneration Tribunal (DFRT) Determination No. 12 of 2012, Officer Aviation Remuneration Structure (the OARS Determination), DFRT Determination No. 11 of 2013, ADF Allowances (the Allowances Determination) and DFRT Determination No. 2 of 2017, Salaries (the Salaries Determination), made under section 58H of the *Defence Act 1903* (the Act) and in accordance with subsection 33(3) of the *Acts Interpretation Act 1901* (AIA Act). The Principal Determination sets out provisions dealing with salary for members of the Australian Defence Force (ADF).

The purpose of this Determination is to do the following.

- Amends the OARS Determination as a consequence of changes made to the Defence Regulation 2016 in relation to termination of service.
- Amends the Allowances Determination as a consequence of changes made to Defence Determination 2016/19, Conditions of service, and the commencement of DFRT Determination No. 6 of 2024 – ADF Military Factor Framework.
- Amends the Salaries Determination by:
 - Amending the definition of “Officer Aviation” by adding ‘remote pilot’ as a competency stream.
 - Amend a number of employment categories in Navy and Army to align the nomenclature of the employment categories.

Section 1 of this Determination sets out the manner in which this Determination may be cited.

Section 2 of this Determination provides that:

- Sections 1 to 4 of this Determination commence on the date of signature.
- Schedule 1 of this Determination commences on the later of the date of signature and the commencement of Defence Amendment (RCDVS Implementation) Regulations 2025.
- Schedules 2 and 3 of this Determination commence of the date of signature.

Section 3 provides that this instrument has authority under section 58H of the *Defence Act 1903*.

Section 4 provides that each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

Schedule 1—Officer Aviation Remuneration Structure Determination amendments

Item 1 amends paragraph 8(c) of the OARS Determination to make updates consequential to changes being made to section 24 of the Defence Regulation on 15 December 2025. The amendment updates the language used in the Regulation in relation to termination of service.

Schedule 2—ADF Allowances Determination amendments

Item 1 repeals section A.1.3 of the Allowances Determination, which provides a list of DFRT determinations repealed by the Principal Determination when it first came into force. This action required by this section is complete and it serve no ongoing legislative purpose.

Item 2 amends section A.1.6 of the Allowances Determination, which provides definitions. The amendment repeals the definitions for calendar day, force and part-time leave without pay, as they are no longer used in the Allowances Determination.

Item 3 amends section B.3.2 of the Allowances Determination, which provides the definition of ‘member with dependants (unaccompanied)’. The definition is repealed and substituted with a definition of ‘unaccompanied resident family’, which is now used in Defence Determination 2016/19, Conditions of service in place of member with dependants (unaccompanied).

Items 4 and 5 amend sections B.3.5 and B.3.7 of the Allowances Determination, which use the phrase ‘member with dependants (unaccompanied)’. As a consequence of item 3, the ‘member with dependants (unaccompanied)’ has with references to ‘unaccompanied resident family’.

Schedule 3—Officer Aviation amendments

Item 1 amends section A.1.12 of the Salaries Determination, which provides specialist officer definitions. The definition of ‘Officer Aviation’ has been amended to insert the competency stream of ‘remote pilot’.

Schedule 4—Employment category amendments

Items 1 to 5 amend Part 2 of Schedule B.2 of the Salaries Determination, which provides the Officer employment categories for Navy. The items amend the tier classification of the ‘Information Warfare Officer’ employment category under pay grades 4 to 8 to reflect the nomenclature of the Military Career Pathway.

Item 6 amends Part 2 of Schedule B.9 of the Salaries Determination, which provides the Warrant Officer Class 1 employment categories for Army. The item amends the nomenclature of the employment category ‘Light Cavalry Scout Warrant Officer’ to ‘Light Cavalry Training Warrant Officer’.

Items 7 to 17 amend Part 2 of Schedule B.11 of the Salaries Determination, which provides the other rank employment categories for Army. The following amendments have been made.

- Items 7 and 10 insert the new ‘Chef’ employment categories into pay grades 2 and 3.
- Items 8 and 11 omit the ‘Cook – Grade 3’ and ‘Cook – Grade 4’ employment categories from pay grades 2 and 3.
- Items 9, 12, 14 and 16 omit and substitute the ‘Light Cavalry’ employment categories in pay grades 2 to 6. These items amend the nomenclature of the employment category.
- Items 13, 15 and 17 omit and substitute the ‘Ammunition Supply’ employment categories in pay grades 4 to 6. These items amend the nomenclature of the employment category.
